Online Debate/Essay Competitions will be employed while celebrity's social media and traditional media advocacies and campaigns will also be deployed.

The main goal of the project is to reduce ignorance and myth around migration to Europe and other western destinations through aggressive advocacies and mass media engagement. The project is primarily targeted at young people between 12-35 of age. 1.0 Background

The Migration Information and Communication Campaign (MICC II) is an extension of the MICC Nigeria Phase 1 (one) Project. It was designed primarily to consolidate on the achievements of the pilot project which is, contributing to the reduction in the incidences of irregular migration and human trafficking in Nigeria through strategic and aggressive advocacies and innovative media engagements.

Objectively, the MICC II Project was designed to deliver improved awareness and higher level of understanding on the dangers and implications of irregular migration and human trafficking (TIP and SOM) in the country, particularly the target locations. The project had Delta state and the FCT as the focus, has Road Show, Town Hall meetings, online Quiz Competition was employed while celebrity's social media and traditional media advocacies and campaigns were also be deployed.

The main goal of the project is to reduce ignorance and myth around migration to Europe and other western destinations through aggressive advocacies and mass media engagement. The project primarily targeted young people between 12-35 of age. However, there were secondary targets such as the traditional, religious, political, women and youth groups, organizations and their leaders.

The project is unique and different in many ways to the existing interventions by either the government or other stakeholders in the targeted locations. The advocacy strategies was carried out on new/social media and selected celebrities who related with grassroots to advance the messages on irregular migration of men, women and children in Nigeria.

1.1. Africa Youth Growth Foundation and Project Stakeholders

The Africa Youth Growth Foundation was founded in 2003 but incorporated in 2006 to address issues and challenges of irregular



migration and its push factors like poverty, unemployment and socioeconomic exclusion facing young people; leveraging on partnership with other partners and stakeholders with shared objectives to achieve same.

Armed with its values; Integrity, Mutual Respect, Fairness and Justice, Transparency and Team Work: The AYGF was chiefly in charge of organizing the MICC II Nigeria Project but with close working relationship of several stakeholders including the state governments of the targeted states, selected celebrities, activists, local civil society organizations and Community Based Organizations (CBOs), religious, traditional and youth organizations and their leaders in the targeted locations etc.

1.2. MICC Nigeria II Project Objectives

The following are some of the changes achieved through the instrumentality of his project:

- Increased stakeholders' investment and participation in reducing incidences of irregular migration from the targeted locations.
- Greater awareness and understanding of the causative factors and the dangers of irregular migration particularly among young people.
- Reduced incidences of irregular migration to Europe and deaths on the Mediterranean Sea and Sahara Desert.
- On the medium and long-term basis, the project would help in the reduction in the number of human trafficking, slave camps and forced labour at countries of origin, transit and destination.

2. MICC Nigeria II Activity Brief

The MICC II Nigeria Project kicked off after the signing of the MoU between the Embassy of the Federal Republic of Germany and the Africa Youth Growth Foundation (AYGF). Furnished below in this section is a detailed brief of the activities that was carried out in furtherance to the realization of the objectives of the project.



2.1. MOU Signing

The Memorandum of Understanding (MoU) between the Embassy of the Federal Republic of Germany and the Africa Youth Growth Foundation (AYGF) for the execution of the Migration Information and Communication Campaign (MICC II Nigeria), was signed on Tuesday 15th March 2021 after which implementation commenced.

2.2. Stakeholder Engagement

In furtherance to the realization of the objectives of the MICC II Nigeria Project, the project team undertook the preparation of notification and visitation letters early on in the Project and the dispatch of same to all stakeholders identified for targeted advocacy on the Project for a crosssection of reasons as:

- Endorsement of the Project with picture and video outputs;
- Inputs on messages communicated to foster ownership and a sense of inclusiveness in the process;
- Approval and support (chiefly government institutions); and,
- Actual advocacy on relevant key issues among others.

The Team continued the process of active follow up to ensure all engagements were carried out so as to drive synergistic impact. The first stakeholder engagement landmark was the Press Conference.

2.3. Project Press Conference

The Project identified the need for a Press Conference to launch the MICC Nigeria Campaign; this decision was taken during the critical review of the strategy for the MICC Nigeria Project through the instrument of the Desk Review process and was considered key to strategic engagement of the public, the Press as well as key stakeholders centric to the mandate of the Project.

The Project Team identified and invited media houses for coverage of the MICC II Nigeria Press Conference. Furnished below are media agencies that were engaged.

The German Foreign Office represented by Leif Stroessner and National Human Rights Commission was part of a cross section of stakeholders identified and engaged for the press Conference.

The Press Conference was held on 9^{th} April, 2021 at the AYGF head office Abuja and lasted 10:00am to 12:00 pm.

A well planned and executed process of strategic media projection and syndication of the event was done across traditional and social media platforms while news tracking and proper reporting was also done.

2.4. The National Youth Service Corp (NYSC Dance and Drama Show)

In furtherance to the realization of the objectives of the MICC II Nigeria Project, AYGF hosted a dance and drama show at the Abuja NYSC Orientation camp, held on the 27th and 28th of May 2021. The project team highlighted the central theme of the campaign and also sensitized Corp members on the dangers of Irregular Migration and its attendant consequences. Corp members were further encouraged to migrate through regular means to preserve their dignity and human rights.





2.5. ENGAGEMENT OF CELEBRITY

The Project's communications desk worked closely with the Management for the identification and engagement of celebrity advocates for the MICC Nigeria Project to drive its social media campaign activity. Endorsement of the MICC Project by the engaged celebrity advocates was also syndicated across diverse media platforms as part of the first major activities to give voice to the MICC II messages via the instrumentality of social media platforms.

Contract Signing with engaged celebrities was carried out and the project's communication desk is tracking and following up activity schedules and actual implementation in that regard.

2.6. THE MICC II ROAD SHOW IN DELTA STATE

As a component of the Migration Information and Communication Migration its Campaign, AYGF held Information and Communication Campaign (MICC II Nigeria) Road Show in Delta state on 29th July, 2021. The event which kicked off at 10:00AM from Interbau Roundabout to Arcade in Asaba Delta state, witnessed a turnout of over 200 people with representatives from organizations such as NAPTIP, Nigerian Red Cross Society, Rotary Club, National Orientation Agency, Delta State Polytechnic, Ministry of Women Affairs, Nigerian Police Force, Ministry of Higher Education and National Human Rights Commission just to mention a few.

The procession was led by the Dr. Arome Salifu, Executive Director AYGF and key members of the Delta State Taskforce on Human



Trafficking and Irregular Migration alongside students from various tertiary institutions in the state, carrying and show casing the campaign banner and placards to several kinds of passers-by on the street.

During the event, AYGF held sensitization talks on the issue on irregular migration, ensuring that the campaign messages were passed across to the general populace that witnessed the event. In the same vein. AYGF staff and volunteers on the ground shared campaign flyers and storybooks containing the dangers and consequences of irregular migration as well as stories of irregular migrants who are now returnees. The location of the road show which spanned 5km was strategically chosen in order for the procession to go through key places in the state such as the popular Ogbeogonogo Market, Shoprite Mall, Asaba Post Office, Saint Patrick Catholic Secondary School and the Federal Medical Center. This was done to ensure that the messages being passed across to the people got maximum reach and impact as persons who received the campaign flyers and storybooks were rather eager to get more information on the subject matter as they requested for extra IEC materials to give to their family and friends who were not present at the time. Members of the press were equally on ground to cover the event from beginning to end. Also, The Federal Road Safety Corp and Nigerian Police Force were on ground to ensure the safety of all persons in attendance and to control vehicular movements during the entire Road Show.



The Road Show eventually terminated at Arcade, Asaba, Delta State, about 5km from the starting point at Interbau Roundabout. The Executive Director, Dr. Arome Salifu gave closing remarks and thanked all stakeholders and persons present for attending the road show and contributing to its success. Refreshments were shared afterwards and all participants departed, marking the end of the successful Road Show.



2.6.1. THE MICC II TOWN HALL MEETING IN DELTA STATE

In the bid to syndicate and harmonize all activities under the Delta state Implementation of the MICC II Nigeria Project, AYGF held a campaign Town Hall Meeting on 30th July 2021, at Orchid Hotels Asaba, Delta State. The Meeting commenced at 9:00AM with the arrival and registration of all guests in attendance. The meeting officially began with introduction of the key stakeholders present and their representatives. This was followed by taking the 2nd stanza of the national anthem then Dr. Arome Salifu gave opening remarks, welcoming all the guests present at the town hall meeting and equally giving a detailed account of the progress of the campaign in Delta state.



Opening Remarks and Goodwill Massages

The next item on the agenda for the day was Goodwill messages from key stakeholders in Delta state such as the Bureau of Orientation, Nigeria Immigration Service, National Human Rights Commission, Delta State Taskforce on Human Trafficking and Irregular Migration, State Attorney General, Peter Mrakpor SAN, and Dr. Genevieve Mordi. HRM Obi Kikachukwu SSA international Affairs, Delta State. The presence of these key stakeholders and their goodwill messages set an important precedent for the day that the essence of being gathered is for none other than to spread more awareness on the issue of Irregular Migration and to create a higher level of understanding in the minds of the people on the dangers and consequences of Irregular Migration.

Furthermore, the Executive Director, Dr. Arome Salifu gave a presentation on the Migration Information and Communication campaign where he went into the core objectives and goals of the campaign including to spread awareness on the issue of Irregular Migration. He also gave an overview on the organizations strategy to achieve the goals of the campaign which include strong social and traditional media engagement through radio shows, TV appearances and advertisements, Celebrity engagement, advocacy visits, town hall meetings and road shows as key outreach strategies to achieving the objectives of the campaign.

Following the presentation by the Executive Director was a presentation by the campaign celebrity – Mr. Real. As a result of his great influence on social media and his strong ability to connect with the youth population the celebrity Mr. Real was picked by the organization to serve as its Campaign celebrity. He was present at the Town Hall Meeting in Asaba where he officially endorsed the campaign and also shared his own experience with trying to migrate to Canada in 2019, this story went a long way in resonating with the guests at the meeting as it was a story a number of people could relate to. After his speech on irregular migration where he



urged the general public to migrate the right way and not through irregular means he went further to give a brief performance of one of his hit songs. His performance was followed by group photographs with guests endorsing the campaign.

Also, in the bid to educate more persons, shed more light and create a higher level of awareness on the issue of irregular migration, there was a presentation made by Superintendent, Kevin Gusom of the Nigeria Immigration Service on Irregular Migration. In his presentation he carefully delineated the major push factors of migration, steps to migrating the right way, labor laws and policies of countries with high levels of immigrants, the dangers and consequences of irregular migration and the steps to take and appropriate authorities to report to when we see or hear of persons being trafficked.

Following the presentation stated above, AYGF Secretariat played a documentary showing the stories of actual persons that had being trafficked or migrated irregularly and had luckily found their way back to Nigeria. The essence of the documentary being played was to bring people in touch with real life stories and experiences so as to domesticate the notion that regular Nigerians have gone through devastating experiences in trying to migrate without following due process and hence they can see through the heartwrenching experiences of these individuals telling their stories, that the consequences of irregular migration can be very severe.

Furthermore, after the documentary had been played, followed and question and answer session by guests to the key stakeholders. This session allowed for brainstorming between guests and the key stakeholders on how to avoid migrating irregularly and the steps to avoid being trafficked. The session also allowed for individuals to broaden their knowledge on updated travel policies and regulations therefore increasing their knowledge on the subject matter.





The town hall meeting finally

drew to an end with a vote of thanks conducted by the Executive Director AYGF, Dr. Arome Salifu. He thanked the key stakeholders present at the meeting for gracing the event with their presence and contributing to its overall success. He equally thanked all those that were invited and participated in the road show and town hall meeting, stating that the campaign in Delta state would not have been a success without them. He also went further to give special recognition to the Delta State Taskforce on Human Trafficking and Irregular Migration for their fantastic work on the ground that aided the overall success of the Migration Information and Communication Campaign (MICC II Nigeria) in Delta state.

2.7. MICC II ROAD SHOW –ABUJA, 3RD NOVEMBER 2021

As a component of the Migration Information and Communication Campaign, AYGF held the second Migration Information and Communication Campaign (MICC II Nigeria) Road Show in Abuja on 3rd of November, 2021. The walk kicked off at 10:45AM from Unity Fountain, Abuja. The show witnessed a turnout of over 143 people with representatives from organizations such as NAPTIP, Federal Ministry of Labour and Employment, National



Orientation Agency, University of Abuja, Nile University of Nigeria, officials from the Nigerian Police Force, Ministry of Higher Education, and National Human Rights Commission to mention a few.

The procession was led by AYGF Program team, and key members of the Federal Road Safety Corps alongside students from various tertiary institutions in Abuja, carrying the campaign banner and placards.

During the event, Dr. Arome Salifu, Executive Director-AYGF alongside other key stakeholders at the event held sensitization talks on the issue of irregular migration, ensuring that the campaign messages were disseminated to the public. AYGF staff and volunteers shared campaign flyers and storybooks containing the dangers and consequences of irregular migration as well as stories of irregular migrants who are now returnees. This was done to ensure that the messages being passed across to the people got maximum reach and impact as persons who received the campaign flyers and storybooks were rather eager to get more information on the subject matter as they requested for extra IEC materials to give to their family and friends who were not present at the time. Members of the press were equally on ground to cover the event from beginning to end. Also, The Federal Road Safety Corp and Nigerian Police Force were on ground to ensure the safety of all persons in attendance and to control vehicular movements during the entire Road Show.

The Executive Director, Dr. Arome Salifu gave closing remarks and thanked all stakeholders, students, and persons present for attending the road show and contributing to its success. Refreshments were shared afterwards and all participants departed, marking the end of the successful Road Show

2.7.1. MICC II TOWN HALL MEETING ABUJA-4TH NOVEMBER, 2021

In the bid to syndicate and harmonize all activities under the Federal Capital Territory Implementation of the MICC II Nigeria Project, AYGF held a campaign Town Hall Meeting on the 4th of November 2021 at Nile University of Nigeria, Idu Abuja. The Meeting commenced at 10:19AM with the arrival and registration of all guests in attendance. Which was followed by an opening prayer from the second stanza of the National Anthem and an introduction of dignitaries and their representatives.

• Opening Remarks and Good will massages

Dr. Arome Salifu gave opening remarks, welcoming all the guests present at the town hall meeting and equally giving a detailed account of the progress of the campaign in the country.



He equally mentioned the importance of the event clearly stating the objective of the project as above. He further called on the three tiers of government to join in the fight against poverty an ill which he states fuels irregular migration.

This was followed by a reading of the goodwill message by the Delta State Governor, Dr Ifeanyi Okowa represented bv Dr. Genevieve Mordi, Senior Special Assistant (SSA) to the Governor on International Affairs. During the reading, she commended the effort of AYGF on the program, as she extended the goodwill of the governor and the people of the state to AYGF in curbing irregular migration, the Governor noted that migration is not a new phenomenon, hence the need for individuals to migrate regularly. The governor lauded the German government in their efforts to curb human trafficking noting that the state was glad to be part of the project. He added that the event would push in creating awareness to the society on the ills of irregular migration. The governor further advised that it was



pertinent for migration to be done by regular means, stating that he had inaugurated a rehabilitation program, GES, TEF to imbibe and rehabilitate victims of irregular migration into the society.

Mr. John Kane from the British High Commission, Head, Collaboration against Trafficking and Smuggling Between Nigeria and Niger who represented the British High Commissioner Catherina Line commended AYGF for the initiative and called for counter measures in combatting irregular migration. He stated that all hands should be on deck to change the narrative coined online and by the media noting that we can use the same tool in fighting the 'enemy'. He further called for individual responsibility as trafficking can be done to anyone citing an example of a relative who was a victim.

After his speech The Secretary of the National University Commission, Prof. Abubakar Rasheed represented by Adeola Adetunji thanked AYGF for the great initiative and also thanked the government for their support, even as he noted that the statistic of irregular migration was worrisome.

Celetine, Chief Mission of Furthermore, Frantz represented Barr. Elizabeth Poage, bv National Officer, IOM noted that IOM has supported the Programme Nigerian Ministry of Labour as well as other relevant agencies in supporting migration labour on the National Policy on migrant labour between 2017 and 2021. She applauded AYGF on the MICC project, noting that IOM was pleased with the project which was reviewed by stakeholders adding that a review would be sent to the ministry of labour to examine challenges faced by victims. She further applauded AYGF for the successful implementation of the MICC II project noting that the outcome of the project would contribute immensely to improving the overall labour migration governance in Nigeria.

This was followed by a speech by Lisa Apitz, First Secretary the Migration and Human Assistant Federal Foreign Office Germany represented by Rolli Okwu where she noted that the German government began supporting AYGF in order to promote regular migration and reduce irregular migration by providing awareness and details for migration. She further noted that about 600,000 Nigerian migrants are living in Germany adding that half of them are students. She further stated that it was pertinent for migration to be done the right way as migration is as old as man. She concluded by commending the AYGF and called for more efforts in curbing the growing ill.

This was followed by a presentation of paper by Dame Juli Okah Donli, Founder of the Roost Foundation addressing the 'causes, patterns and impacts of Irregular migration' and pointed out the causes which include poverty, ignorance, greener pasture mentality, peer pressure, greed, and war. She further noted that irregular migration is not only a Nigerian problem but a global problem. She further expatiated on the challenges inherent in the tackling of irregular migration which include; Limitation in the conduction of joint investigations and operations within countries, inadequate funding, social unrest, poor economic situation, porosity of the boarders, corruption of law enforcement officers, ignorance in rural areas, unfriendly labour laws for girls under 18, lack of internet facilities. She offered solutions to this problem to include: Support elaboration and implementation of comprehensive national and regional migration and mobility, encourage development and implementation of a national and



regional strategies or policies for integrating migrants into host society, all government authorities should review all bilateral and multilateral treaties.






